Indépendance AM opens new direct access to its Europe Mid fund with an active ETF



Indépendance AM announces the launch of an ETF share class of its Europe Mid fund, listed on Euronext Paris. This new share class provides investors with three key benefits: execution at a known price, immediate liquidity, and easier access through trading platforms, while retaining PEA (French equity savings plan) eligibility.

Available since mid-December 2025, this new share class is fully in line with the approach Indépendance AM has developed over the past thirty years: an active, conviction-driven, disciplined management style focused on long-term performance.

With this ETF share class, Indépendance AM is not creating a separate product from its historical strategy. The firm is giving access, through a different subscription channel, to the same management standards applied to the Europe Mid fund.

This evolution responds to a growing investor demand for clearer, more responsive and easier-to-access solutions, without compromising on the quality of active management.
